**WEB SITE and Image (incl Digital Image) Acquisition and Use Policy 2010**

MESC has a WEB site [www.mesc.org.au](http://www.mesc.org.au) which we are going to continue to use and expand to include up to date information and items of interest to our players and supporters. From time to time, we would like to include photos of our players, which could be the result of a “player of the match” or even a team photo. After discussions with our sponsoring church, Citipointe, and the QCSA, our WEB site policy has been enhanced to further underpin the control of members information. The policy has two main parts.

Part 1. As a member or parent/guardian of a member, you agree where information such as sporting achievements, player activities, photographs and video material and other news, is collected by MESC, it may be published in the MESC Newsletter, magazine and on our MESC web site or may be used for promotional purposes. Under no circumstances will members under 18 years of age be identified by use of their full personal name on our web site. For security reasons, the only personal information we would associate with a photo of a player is their first name on our web site.

Part 2. Further, as a member or parent/guardian of a member, you agree where information such as sporting achievements, player activities, photographs and video material and other news, is collected by you as a member or parent/guardian of a member, you will **not** publish them or cause them to be published except for personal private in home use and will **not** publish any materials for public display without written approval from the President of MESC. Failure to comply with this section 2, may result in disciplinary action within the club, and may be subject to legal challenge by authorities

**Privacy Policy (Information Collection)**

In order for our Club to run effectively, we are required by QCSA to collect information about players. This section outlines how we handle that information. We comply with the requirements of the National Privacy Principles as promulgated by the Privacy Commissioner. The following points are information you should be aware of.

- (a) Any inquiries regarding personal information should be made to The Registrar, Mansfield Eagles Soccer Club Inc., PO Box 2160, Mansfield Q 4122.
- (b) You are able to access your own personal information we hold by contacting the above. While we endeavour to maintain accurate, complete and up-to-date data, you have the right to contact us to correct any errors at the above address.
- (c) Personal information is required by our club in order to; draw up team lists, organize game draws, register the players with the Queensland Christian Soccer Association in order to be able to play in this tournament, provide ID cards in order to verify identity of players in matches, allow coaches and officials to contact players to organise practice games, matches and other events, contact players with information on our club activities and in the event of a mishap, contact relatives of players.
- (d) At sign on day we do collect information on behalf of players for registration with the Queensland Christian Soccer Association, and this information is passed to them. Information may be passed from the Queensland Christian Soccer Association to 3<sup>rd</sup> Parties for the purpose of providing insurance cover for players.. We do not have control over information collected by the Queensland Christian Soccer Association. We do not disclose personal information to any other individual or organization.
- (e) It is your right to refuse to provide personal information, but in that case it may not be possible for players to compete in our matches.
- (f) Personal data is kept in a secure location, and information that is no longer required is permanently destroyed.
- (g) If you have any concerns about specific privacy issues, please contact the Registrar, at the above address or the MESC web site.
